THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

I, hereby give notice, under Sub-Section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act No. 28 of 1964, that the Government intends to acquire the following land/servitude right which is required for a public purpose.

Description of the Land/Servitude to be Acquired:
