Part 11**Appendix One**

The following contents will be substituted in place of all the Sections stated under (i), (ii) and (iii) of Sub No. 2.2 of Appendix One.

- 2.2 Qualifications for recruitment of the internal applicants by a limited competitive examination and an interview to examine the qualifications.
- 2.2.1 For the Posts of Assistant Government Printer (Production), Assistant Government Printer (Maintenance) and Assistant Government Printer (Printing Editor):
- (a) Should be an officer in Supervisory Management Assistant (Technological) Service Category in the Printing Service with a period of service of not less than 15 years in a Departmental Post (Management Assistant Technological Service Category) in the Department of Printing.
 - (b) Should have obtained certificates after following 02 courses in Printing in the Sri Lanka Printing Institute or a recognized institution. (Duration of a course should not be less than one year).
 - (c) Should not have been subjected to disciplinary punishment as per the provisions set out in Public Service Commission Circular No. 01/2020 and the circulars incidental thereto.
