2020 - FIRST SUPPLEMENTARY FINANCIAL STATEMENT

Granting Permission by virtue of Powers vested in me under Section 27(A) of Provincial Council Acts No. 42 of 1987 as the term of the Sixth Sabaragamuwa Provincial Council of the Democratic Socialist Republic of Sri Lanka ended on 26th September, 2017 - 2021

1. This permission may be cited as "Permission to disburse under first supplementary financial statement -2021 of the Sabaragamuwa Provincial Council" and come in to operation from 09.08.2021.
2. The expenditure of the Sabaragamuwa Provincial Council which is estimated Rupees Thirty Seven Billion Four Hundred and Twelve Million Only (Rs. 37,412,000,000.00) for the service of the period beginning on 01st of January, 2021 and ending 31st December 2021, which is specified as "Financial Year 2021" in the Annual Financial Statement and Revenue Expenditure Estimates prepared for the year 2021, that was approved on 27.11.2020, is hereby amended as, Rupees Thirty Nine Billion One Hundred and Sixty Four Million Two Hundred and Sixty Eight Thousand Four Hundred and Forty Three and Cent Ninety Six Only (Rs. 39,164,268,443.96) and grant permission to the Chief Secretary of this Province and other Accounting Officers to disburse the same from the Sabaragamuwa Provincial Council Fund.
3. Accordingly the first Schedule of the Annual financial statement and Revenue- expenditure estimates- 2021, is amended as the first Schedule hereof and grant permission to disburse the same.
4. This permission will be valid till 31st of December, 2021 or upto the date that expires three months (03) from the date of summoning the Seventh (07th) Sabaragamuwa Provincial Council or from the date re-start the functions of the Sabaragamuwa Provincial Council which occurs first.
