LAND ACQUISITION ACT (CHAPTER 460)

REGULATIONS made by the Minister of Lands under Paragraph (f) of Sub-section (2) of Section 63 of the Land Acquisition Act (Chapter 460), approved by Parliament of Sri Lanka on 11th November, 2021.

Regulations

The land acquisition (payment of compensation) Regulations, 2013, published in *Gazette Extraordinary* No. 1864/54 of May, 30, 2014 as amended, from time to time, is hereby further amended as follows :-

- (1) in sub-paragraph (z) of paragraph (2) of regulation 2 thereof, by the substitution for the words "Expressway Extension project." of the words "Expressway Extension Project;"
- (2) by the insertion immediately after sub-paragraph (z) of paragraph (2) of regulation 2 thereof the following sub-paragraphs :-



"(aa) North Central Maha Ela Project ;

- (i) North Central Maha Ela Project (UEC-ICB-2A)-
construction of the canal through the tunnel from Koduruwawa to Namalpura-total length 28.09Km;
 - (ii) North Central Maha Ela Project (UEC-ICB-3)-
from Kongatiya Tank to Koduruwawa - total length 21.2Km;
 - (iii) North Central Maha Ela Project (UEC-ICB-4)-from Namalpura to Yakalle - total length 9.9Km;
 - (iv) North Central Maha Ela Project (UEC- ICB-5)-
from Yakalle to Eruwewa and Mahakanadara Oya-total length 29.9Km;
- (ab) Lower Malwathu Oya Multipurpose Development Project;
(ac) Mundeni Aru River Basin Development Project;
(ad) Kubukkan Oya Reservoir Project;
(ae) Thalpitigala Reservoir Project;
(at) Kirindi Oya Irrigation and Settlement Project;
(ag) construction of Pethiyagoda proposed Pump House;
(ah) construction of Ellewewa Reservoir;
(ai) Wemedilla Reservoir Project;
(aj) construction of Weupitiya tank;
(ak) upgrading the capacity Poona Wewa of the Dambavinna Project;
(al) construction of Hakirilla Tank;
(am) widening the estuary of Kirama water droplet;
(an) acquisition of lands with the Halpathota Mechanical Engineering Workshop and its office;
(ao) main canal of Mahara Bandara Wewa of the Udugoda Bandara Ela Project;
(ap) Mah Oya Reservoir;
(aq) construction of Catchment Canal Project from Siyabalangamuwa Oya to Maha Galgamuwa Tank; and
(ar) Gin Nilwala Project."
