SRI LANKA ELECTRICITY ACT, No. 20 OF 2009

Order under Section 52

BY virtue of the powers vested in me, by Section 52 of the Sri Lanka Electricity Act, No. 20 of 2009, and upon the recommendation made by the Minister assigned the subject of power, I, Gotabaya Rajapaksa, President of the Democratic Socialist Republic of Sri Lanka being of the opinion that -

- the land specified in the schedule hereto is urgently required for the construction of a 220/132 kV Switching station as a power transmission project; and
- the said power transmission project being a public purpose would serve for the general welfare and benefit of the public,

do by this Order declare that the said land is required for such purpose.
