### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Samarakoon Mudiyansele Chandrasena, Minister of Lands do hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Allotments of land described in below names and extents depicted in the Advance Tracing No. KA/HOR/2018/448 dated 10.05.2019 prepared by the Surveyor General, situated in the village of Millewa in the Divisional Secretary's Division of Horana in Kaluthara District of the Western Province and bounded as follows:

#### 01. Lot A – Millewa Estate (Part A) - Extent : About 0.6708 Hectare

North: Road and Lot B; East: Lot B and Lot D; South: Lot D and Millewa Estate claimed by State; West: Millewa Estate claimed by State and Road.

#### 02. Lot B – Millewa Estate (Part A) - Extent : About 0.0886 Hectare

North: Road and Millewa Estate claimed by State and Lot C; East: Millewa Estate claimed by State, Lot C and Lot E; South: Lot E, Lot D and Lot A; West: Lot D and Lot A.

#### 03. Lot C – Millewa Estate (Part A) - Extent : About 0.4079 Hectare

North and East: Millewa Estate claimed by State; South: Millewa Estate claimed by State and Lot B; West: Lot B.



**04. Lot D – Millewa Estate (Part A) - Extent : About 0.3914 Hectare**

North: Lot A and Lot B; East: Lot B and Lot E; South: Lot E and Millewa Estate claimed by State; West: Millewa Estate claimed by State and Lot A.

**05. Lot E – Millewa Estate (Part A) - Extent : About 2.4082 Hectare**

North: Lot D, Lot B, Millewa Estate claimed by State, Road and Lot F; East: Lot F, Road and Millewa Estate claimed by Estate; South: Millewa Estate claimed by State, paddy field of which the claimant could not be traced and Depa Ela; West: Paddy field of which the claimant could not be traced, Depa Ela and Millewa Estate claimed by State.

**06. Lot F – Millewa Estate (Part A) - Extent : About 0.1987 Hectare**

North: Road; East, South and West: Lot E.
