As the Mayor of the Badulla Municipal Council of the Uva Province has prepared the Budget for the year 2022 in accordance with Section 211 of the Municipal Councils Ordinance and submitted it to the Council for final consideration in terms of Section 213 of the Municipal Councils Ordinance, for the reasons it has not been passed and due to non-compliance with



Section 7 of Local Authorities (Special Provisions) Act, No. 21 of 2012, the post of Mayor should be deemed to have been vacated with effect from 31.12.2021 midnight and the post of Mayor of the said Badulla Municipal Council shall be deemed to have become vacant with effect from the above mentioned date.

ORDER

As the post of Mayor of the Badulla Municipal Council has become vacant under Section 7 of the Local Authorities (Special Provisions) Act, No. 21 of 2012 due to the failure to pass the budget report for the year 2022 of Badulla Municipal Council in the Badulla District of the Uva Province in accordance with the requirements of Sections 215 and 215A of the Municipal Councils Ordinance, I hereby inform that the powers, duties, functions of the above post is handed over to the Deputy Mayor in accordance with Section 14 (6) of the Municipal Councils Ordinance, in order to perform and implement the above from the date of vacancy until the vacancy is filled as per the Local Authorities Elections (Amendment) Act, No. 22 of 2012.

Further, I hereby order the Deputy Mayor of the Badulla Municipal Council on the recommendation of the Municipal Commissioner of the Badulla Municipal Council and prior approval of the Commissioner of Local Government to incur the expenditures relevant to the recurrent expenditure for the year 2022 and the essential expenditures relevant to the ongoing projects including the L.D.S.P. project to ensure the continuation of the activities of the Badulla Municipal Council until the newly appointed Mayor presents the budget for 2022 to the council and pass the budget.
