FILLING OF A VACANCY IN THE OFFICE OF MEMBER OF THE KEGALLE URBAN COUNCIL UNDER SECTION 66A(1)(a) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of the member of Kegalle Urban Council has fallen vacant by the reason of Death ;

FILLING OF A VACANCY IN THE OFFICE OF MEMBER OF THE KANDY MUNICIPAL COUNCIL UNDER SECTION 66A(1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of return member of Kandy Municipal Council has fallen vacant by reason of failing to attend three consecutive general meetings of the council without leave of the Council first obtained ;
