THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Samarakoon Mudiyanseelage Chandrasena, Minister of Lands, do hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the Land described below are needed for a public purpose and will be acquired under the provisions of that Act.

The Allotments of land called by below given names and in extents, described in the Advance Tracing No. GA/BIY/2019/494 and dated 17.09.2019 of the Surveyor General, situated at the village of Heiyanthuduwa, in Heiyanthuduwa South Grama Niladhari Division, No. 275A, Adhikaripaththuwa Minor Division, in the Divisional Secretary's Division of Biyagama, in Gampaha District, Western Province and bounded as follows.

01. Lot 'B' – Delgahawatta – Extent About: 0.0088 Hectares (3.47 perches)

North: Land bearing Assmt. No. 0215//063 at Sri Dewamiththa road and remaining portion of the said land; East: Lot A, land reserved for the highway and remaining portion of the said land; South: Remaining portion of the said land; West: Road, Lot D, C and land bearing Assmt. No. 0215/063 at Sri Dewamiththa Road.

02. Lot 'C' – Delgahawatta – Assmt. No. 0215/063 Sri Dewamiththa Road – Extent About: 0.0021 Hectares (0.83 perches)

North: Remaining portion of the said land; East: Delgahawatta claimed by W. D. Deepal Rodrigo and Lot B; South: Lot B and D; West: Remaining portion of the said land.

03. Lot 'D' – Extent About: 0.0004 Hectare (0.15 perches)
