THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Samarakoon Mudiyansele Chandrasena, Minister of Lands do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments depicted in the Advance Tracing No. MAHA/AKR/2017/629 dated 23.04.2018 prepared by the Surveyor General, situated in the village of Pangollamada of Rathukoho Grama Niladhari Division No. 575 in Udagampaha Korale Minor Division in the Divisional Secretary's Division of Akurana in Kandy District of Central Province and bounded as follows:

01. Lot 'A' - Heepitiyawatte - Extent: About 0.0161 Hectare
