I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as Amended by The Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land/servitude which is required for a public purpose.

Description of the land or servitude to be acquired:

One allotment of land in total extent of 0.0230 Hectare known as Lot No. 1 in Preliminary Plan No. ක 4834 dated 22.06.2021 prepared by the Surveyor General, situated at Grama Niladhari's Division of 748 A-Polkotuwa, Divisional Secretariat Division of Beruwala in Kalutara District, Western Province, Morefully described as follows.

Lot No. 1 - Name of land: Dummalamodara, Thuduwewatta; Description: Garden; Claimant: State; Original Claimant: Railway Reservation; Extent: 9.1 Perches.

North: Illeperumachchiyawattha vs Illeperumachchiyawatta claimaed by D.
