THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Samarakoon Mudiyansele Chandrasena, Minister of Lands do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Eight (08) allotments of land depicted in the Advanced Tracing No. Aa/NPE/2020/1011 dated 28.12.2020 prepared by the Surveyor General, situated in the Village called Anuradhapura Town (FTP A 2) in the Grama Niladhari Division No. 248, Kanadara Korale Minor Division in the Divisional Secretary's Division of Nuwaragampalatha East in Anuradhapura District of the North Central Province and bounded as follows:

1. Lot 'A' – Nuwarawewa Kale – Extent: 0.0262 Hectare
North: Nuwarawewa Kale occupied by Regional Archeological Office; East: Nuwarawewa Kale occupied by Regional

Archeological Office and road; South: Nuwarawewa spill canal; West: Nuwarawewa spill canal and Malwathu Oya.

2. Lot 'B' – Nuwarawewa Kale – Extent: 0.0972 Hectare

North: Nuwarawewa spill canal; East: Road reservation of Jayanthie Mawatha; South: Nuwarawewa Kale occupied by Regional Archeological Office; West: Cross canal.

4. Lot 'D' – Nuwarawewa Kale – Extent: 0.0782 Hectare
North: Nuwarawewa spill canal; East: Cross canal; South: Nuwarawewa Kale occupied by Regional Archeological Office and Lot E; West: Lot E and Nuwarawewa spill canal.

5. Lot 'E' - Nuwarawewa Kale - Extent: 0.0378 Hectare
North: Lot G, Nuwarawewa spill canal and Lot D; East:
Lot D; South: Nuwarawewa Kale occupied by Aramaya;
West: Lots F and G.

6. Lot 'F' - Nuwarawewa Kale - Extent: 0.0014 Hectare
North: Lots G and E; East: Lot E; South: Aramaya and
Nuwarawewa Kale occupied by Anuradhapura Municipal
Council; West: Lot G.

7. Lot 'G' - Nuwarawewa Kale - Extent: 0.0038 Hectare
North: Nuwarawewa spill canal; East: Lots E and F; South:
Lots E, F and road reservation; West: Road.

8. Lot 'H' - Nuwarawewa Kale - Extent: 0.0333 Hectare
North: Nuwarawewa spill canal; East: Road; South:
Nuwarawewa Kale of which the claimant could not be traced;
West: Malwathu Oya.
