By virtue of the powers vested in terms of paragraph 1 of Article 57(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka, the provisions under No. 17 and 18 of Part I of the Schedule published in the Gazette Extraordinary No. 1941/41 dated 20.11.2015 as amended by the Gazettes Extraordinary No. 1955/22 dated 25.02.2016, No. 2193/30 dated 16.09.2020 and No. 2205/3 dated 08.12.2020 by which the Public Service Commission delegated powers are hereby amended with effect from 18.08.2021.
