THE CUSTOMS ORDINANCE (CHAPTER 235)

Customs Notification No. 2/2021 - Bonded Warehouses

NOTIFICATION MADE BY THE DIRECTOR GENERAL OF CUSTOMS IN TERMS OF SECTION 69 OF THE CUSTOMS ORDINANCE

IN pursuance of the power vested in me by Section 69 of the Customs Ordinance (Chapter 235), I, Ganwarige Vijitha Ravipriya, Director General of Customs, do, with the approval of the Minister of Finance granted by virtue of the powers vested in him by that Section, by this notice publish in accordance with his direction, approve and appoint warehouses and places of security specified under Column 03 of the Schedule I & II annexed hereto, as Public bonds, Manufacture - in -bonds, duty free shops, feeder bonds and Private bonds, in which the goods specified under Column 06 of the said Schedules imported by the importer/owners of such warehouses and places of security may be warehoused, kept and secured without payment of duty on the first entry thereof.
