Notification of the Honourable Governor of the Northern Province

Order under Sub section 185(1) of the Pradeshiya Sabha Act, No.15 of 1987 read with Section 2 of the Provincial Council (Consequential Provisions) Act, No. 12 of 1989

According to the inquiry report dated 02.08.2021 which was handed over to me with its finding, having considered the evidence and documents of the prosecution after an independent inquiry by Mr. Kandiah Ariyanayagam, Retired Judiciary Officer, who was appointed by me under Sub section 02 of Section 185 of the Pradeshiya Sabha Act, No. 15 of 1987 in order to inquire and submit to me a report whether there is any proof of any Disqualifications as per Section 185 (1) of the Pradeshiya Sabha Act, No. 15 of 1987 committed by the Chairman of the Pradeshiya Sabha of Mannar, Mr. Sahul Hameed Mohamed Mujahir, in his capacity as the Chairman and a member of the Pradeshiya Sabha, Mannar by virtue of powers vested in me by the provisions of Sub section 185(1) of the Pradeshiya Sabha Act, No. 15 of 1987 read with Section 2 of the Provincial Council (Consequential Provisions) Act, No. 12 of 1989;

As I am satisfied that there is sufficient proof of the disqualification as stated in Sub section 185(1) (c) (a) of the Pradeshiya Sabha Act, No. 15 of 1987 including abuse and misuse of powers of office against the Chairman of Pradeshiya Sabha, Mannar, Mr. Sahul Hameed Mohamed Mujahir in discharge of the duties and responsibilities of the post of Chairman of the Mannar Pradeshiya Sabha,

I, Mrs. Piencia Sarojinidevy Manmatharajah Charles, Governor of the Northern Province do hereby dismiss Mr. Sahul Hameed Mohamed Mujahir from the posts of Chairmanship and the membership of the Mannar Pradeshiya Sabha with effect from 14 of September 2021, by virtue of the powers vested in me by Sub section 185(1) of the Pradeshiya Sabha Act, No. 15 of 1987 read with Section 2 of the Provincial Council (Consequential Provisions) Act, No. 12 of 1989:
