**Provincial Council Notifications**

**ORDER MADE UNDER SECTION 326 OF MUNICIPAL COUNCILS ORDINANCE (CHAPTER 252), READ WITH SECTION 02 OF THE PROVINCIAL COUNCILS (CONSEQUENTIAL PROVISIONS) ACT No. 12 OF 1989**

I, Roshan Gunathilaka, the Governor of Western Province, in terms of the powers vested in me as per Section 326 (Chapter 252) of the Municipal Councils Ordinance read with Section 02 of the Provincial Councils (Consequential Provisions) Act No. 12 of 1989 do hereby order that all the Municipal Councils of Western Province in their functioning shall, to the relevant degree, accord to procedures described under the Financial Regulations of Democratic Socialist Republic of Sri Lanka on decision making, functioning or defaulting with regard to financial control of Municipal Council Fund until provisions be allocated by a written law relating to any matter not provided for by provisions under Municipal Councils Ordinance (Chapter 252) on determining the procedure for utilization of the money of Municipal Council Fund; or not provided for by orders enforced by Section 289 of the said Ordinance or by By-laws enforced under Section 267 read with Section 272 of the same Ordinance or by a relevant By-law made under Section 03 of the Local Government Authorities (Standard By-laws) Act No. 06 of 1952.

I further announce hereby that considering the matters affecting the total economy, since a need has been created for every Municipal Council as a statutory institution to act in responsibility while utilizing its Fund; to utilize if fairly and



sensibly to preserve public welfare, this order was made considering the requirement arisen to determine the procedure without any administrative-wise obstacle to such utilization.
