THE LAND ACQUISITION ACT CHAPTER 460

Declaration under section 5

I, Samarakoon Mudiyansele Chandrasena, Minister of Lands, do hereby declare under Sub-section (1) of section 5 of the Land Acquisition Act, that the Lands described below are needed for a public purpose and will be acquired under the provisions of that Act.
