All that area of land containing in extent 34.96 hectares depicted by Lot Nos. 1,2,3,4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21,22 and 23 in the Preliminary Plan No. Col. 5529 made in accordance with the maps of the Surveyor Department situated in the villages of Salpitakorale Pallepattu Madiwela and Mirihana within the Nugegoda Divisional Secretary's Division in the District of Colombo in the Western Province, altogether containing in extent 317.2147 hectares.
