2. **Description of the land.**– The allotments of land morefully described in below names and extents in the Advance Tracing No. H/BLA/2019/677 dated 06.12.2019 prepared by the Surveyor General, situated in the Village called Getamanna in Giruwa Pattu South in the Divisional Secretary’s Division of Beliatta in Hambantota District of Southern Province and bounded as follows:
