FILLING OF A VACANCY IN THE OFFICE OF MEMBER OF THE BERUWALA PRADESHIYA SABHA UNDER SECTION 66A(1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS, the office of return member of Beruwala Pradeshiya Sabha has fallen vacant by reason of Death ;
