THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Nalaka Jude Harin Fernando, Minister of Tourism and Lands, do hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

An allotment of land depicted in below names and extents in the Advanced Tracing No. Ya/DLF/2019/238 dated 23.12.2019 prepared by the Surveyor General, situated in the Village called Thalathurai in the Grama Niladhari Division No. J/05 of Delft Center East, in the Divisional Secretary's Division of Delft in Jaffna District of Northern Province and bounded as follows:
