Governor in the North Western Province which has been published in the *Extraordinary Gazette* No. 2238/35 dated 30th July 2021, and the order made under Section 24 (1) of Pradeshiya Sabha Act No. 15 of 1987.

It is further notified that a list of such roads and thoroughfares has been included in the Schedule hereto and every road and thoroughfares included therein shall be deemed as roads and thoroughfares owned by the Pradeshiya Sabha Kalpitiya under sub-section (5) of section 24 of the Pradeshiya Sabha Act.
