**Rules Made Under Section 19(5) of Provincial Councils Act, No. 42 of 1987 and
Article 154 c Read with Article 154 f of the Constitution of the
Democratic Socialist Republic of Sri Lanka**

I, Roshan Goonethileke, the Governor of the Western Province do hereby announce that the "Rules for Amendment of Procurement Affairs Pertaining to the Western Provincial Council Fund", formed as per the powers vested in me under Sub-section 19(5) of the Provincial Councils Act, No. 42 of 1987 and Article 154 c of the Constitution of the Democratic Socialist Republic of Sri Lanka and read with Article 154 f of the same Constitution, shall hereby be declared.

RULES

1. These rules will be enforced to amend the rules governing procurement affairs relevant to the Western Provincial Council Fund.
2. These rules shall be cited as the Rules for Amendment of Procurement Affairs relevant to the Western Provincial Council Fund.
3. Section 12 of the Rules governing the Procurement Affairs relevant to Western Provincial Council Fund included in the *Extraordinary Gazette* of the Democratic Socialist Republic of Sri Lanka No. 2186/26 and dated 30th July 2020 will hereby be amended, numbered as Sub-section 12(1) and substituted consequently with the following Sub-sections.
 - (ii) An appeal relevant to a Procurement decision presented under this section, when forwarded to the Governor of Western Province by the appellant, the relevant appeal should be forwarded after depositing money to the Governor's Secretary of Western Province or to the Procurement Entity relevant to the said procurement according to the value of the procurement which accord to the following mentioned values, together with a photocopy of the receipt relevant to it.

<i>Value of Procurement</i>	<i>Deposit Amount</i>
Over Rs. 250 Million	Rs. 100,000.00
Rs. 200-250 Million	Rs. 75,000.00
Rs. 100-200 Million	Rs. 50,000.00
Rs. 25-100 Million	Rs. 25,000.00
Less than Rs. 25 Million	Rs. 15,000.00

- (iii) Unless the appeal has been forwarded with a copy of the relevant receipt obtained after duly depositing the deposit money, the relevant appeal should not be considered as an appeal made properly under this section and no action should be taken thereon.
 - (iv) Where the decision of the Procurement Committee relating to the relevant procurement activity changes by an appeal forwarded under this section, measures should be taken to release the relevant deposit money to the appellant, whereas, if the appellant's appeal is rejected, relevant deposit money should be credited to the Provincial Council Fund.
4. Should any inconsistency arise among Sinhala, English and Tamil texts of these rules, Sinhala text shall prevail.
