THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Nalaka Jude Harin Fernando, Minister of Tourism and Lands, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of Land Acquisition Act.

The allotments of land are fully described in the names and extents below mentioned, depicted in the Advance Tracing No. KU/KRN/2022/70 and dated 28.11.2022 prepared by the Surveyor General, situated in the Villages of Boyagane and Ganegedara, in No. 829 - Boyagane and 830 - Madithiyawela Grama Niladhari Divisions in the Divisional Secretary's Division of Kurunegala in the District of Kurunegala in the North Western Province and bounded as follows;

01. Lot 'A' - Dediyağaththa paddy Field - Extent : 0.0045 Hectare
