THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Kuragama Don Lal Kantha, Minister of Agriculture, Livestock, Lands and Irrigation do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is required for a public purpose and will be acquired under the provisions of that Act.
