THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Kuragamage Don Lal Kantha, Minister of Agriculture, Livestock, Land and Irrigation, hereby declare, under Sub section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

All that allotment of land depicted in the Advance Tracing B/HLE/2021/261 and dated 29.06.2022, prepared by the Surveyor General, situated at the Village of Ettampitiya (F.V.P. 197), in Pallegama (55 A) Grama Niladhari Division, in Dehivinipalatha Korale Minor Division, in the Divisional Secretary's Division of Hali-Ela, in Badulla District, Uva Province and bounded as follows:
