ORDER UNDER SECTION 53

SCHEDULE II

Rationale for the consideration of the Secondary Business of Strategic Importance

The objectives of the Colombo Port City Economic Commission, as stipulated in section 5 of the Colombo Port City Economic Commission Act, No. 11 of 2021, have been considered in designating the business as a Business of Strategic Importance, in order to ensure the success of establishing the Colombo Port City, having regard to the national interest or the advancement of the national economy as provided for in section 53(5) of the said Act.

AKP LANKA (PRIVATE) LIMITED (AKP Lanka), incorporated in Sri Lanka, is fully owned by Trident Bidco Limited, positioning it as a subsidiary of Acuity Knowledge Partners, a leading global knowledge process offshoring firm headquartered in the United Kingdom. Acuity Knowledge Partners supports over 600 clients in the global financial services sector, employing approximately 6,000 professionals across its delivery centers in India, Sri Lanka, China and Costa Rica. Trident Bidco Limited is the 100% holding company of AKP Lanka and Trident Midco 2 Limited is the 100% holding company of Trident Bidco Limited. Trident Bidco Limited due to its holding company status does not prepare financial statements. Therefore, Trident Midco 2 and its subsidiaries reported an audited revenue of approximately USD 270 million in 2023.

The Primary objective of establishing AKP Lanka within the Colombo Port City is to create a scalable delivery center that supports global financial sector clients, by leveraging the strategic advantages of the Colombo Port City. This initiative aims to attract and retain both local and international talent, thereby facilitating business growth and innovation. The services provided by AKP Lanka will encompass offshore-based solutions in investment research, investment banking, lending, technology development, compliance, marketing and consulting, catering to financial services clients in the US, UK, Europe, and Asia.
