Government Notifications

THE SOCIETIES ORDINANCE

BY virtue of the powers vested in me by Section 3 & 4 of the Societies Ordinance (Chapter 123), I, Wasantha Samarasinghe Minister of Trade, Commerce, Food Security and Cooperative Development do by this notification;

- 1) Authorize the registration of the society namely, PSYCHOLOGY ASSOCIATION OF SRI LANKA of No. 45/7, UNIVERSITY SQUARE, DANGOLLA, KANDY to carry out the following purposes under Section 3 (b) of the Societies Ordinance No. 16 of 1891:
 - (a) to expand the field of psychology as a discipline and as a profession in Sri Lanka;
 - (b) to promote and disseminate knowledge of psychology and its applications;
 - (c) to encourage research with a view to promote professional knowledge of psychology;
 - (d) to regulate the professional activities of the members and maintain proper standards in the development , standardization, use and evaluation of instruments and devices used in the practice of psychology in Sri Lanka;
 - (e) to advise health regulatory bodies, organisations, health services users and general public regarding expertise required to used and interpret psychological tests and advocate for qualification standards for the use of psychological tests;

- (f) to safeguard the professional interest of members and to render assistance to expand the knowledge and professional expertise;
- (g) to render assistance in research, and publication on psychology and facilitate access to relevant materials;
- (h) to establish a Code of Ethical Conduct in order to promote ethical practice and prevent malpractice amongst those involved in the field of psychology;
- (i) to advise on the minimum qualifications required to practice in specialist fields of psychology;
- (j) to organize conferences, workshops and lectures and provide networking opportunities in various areas of psychology;
- (k) to collaborate with other organizations having similar objects to those of the Society in Sri Lanka or abroad; and
- (l) to publish a journal with research, studies, articles and other writings related to psychology and its related disciplines;

The Society shall ensure that the objects in Clause 4 (1) above are carried out without any distinction based on race, religion, language, caste, gender, political opinion, place of birth or otherwise.

2). Exempt the application of the provisions of Section 5 (4) of the Societies Ordinance to the aforesaid Society.
