GRANTING PERMISSION BY VIRTUE OF POWERS VESTED IN ME UNDER SECTION 27 (A) OF PROVINCIAL COUNCIL ACT NO. 42 OF 1987 AS THE TERM OF THE 6TH SABARAGAMUWA PROVINCIAL COUNCIL OF THE DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ENDED ON 26TH SEPTEMBER, 2017.

1. This permission may be cited as “Permission to disburse under the Second supplementary financial statement - 2026 of the Sabaragamuwa Provincial Council” and come in to operation from 31.03.2026.
2. The expenditure of the Sabaragamuwa Provincial Council which is estimated Rupees Seventy Two Billion Seven Hundred Thirty One Million Two Hundred Fifty Thousand Six Hundred Ninety Three and Cents Forty Seven (Rs. **72,731,250,693.47**) for the service of the period beginning on 01st of January, 2026 and ending 31st December 2026, which is specified as “Financial Year 2026” in the Annual Financial Statement and Revenue and Expenditure Estimate for 2026 approved on 25.11.2025, is hereby amended as, Rupees Seventy Three Billion Six Hundred Sixty Four Million Six Hundred Eighty Thousand Six Hundred Ninety Three and Cents Forty Seven (Rs.73,664,680,693.47) and grant permission to the Chief Secretary of this Province and other Accounting Officers to disburse the same from the Sabaragamuwa Provincial council Fund.
3. Accordingly the first schedule of the Annual Financial statement and revenue - expenditure estimates - 2026, is amended as the first schedule here of and grant permission to disburse the same.
