In the event of failure to submit any claim before the above-mentioned date, action will be taken to hold an ex parte inquiry to determine title to the land and accordingly publish such determination in the Government *Gazette* in terms of Section 14 of the above Act.

The Cadastral Map No. 321107 referred to above may be perused at the relevant Grama Niladhari Office, Divisional Secretariat, District Survey Office, Office of the Commissioner of Title Settlement, or the Surveyor - General's Office.
