The Immigrants and Emigrants Regulations, 1956, published in the Supplement to the Ceylon Government *Gazette* No. 10,896 of February 24, 1956 as amended from time to time are hereby further amended in regulation 13 thereof, in the table under the heading "2. Visit Visa" by the repeal of items 1, 2 and 3 stipulated therein and the substitution therefor of the following :-
