1. This permission may be cited as "Permission to disburse under the third supplementary financial statement -2026 of the Sabaragamuwa Provincial Council" and come in to operation from 04.05.2026.

The expenditure of the Sabaragamuwa Provincial Council which is estimated Rupees Seventy Three Billion Six Hundred Sixty Four Million Six Hundred Eighty Thousand Six Hundred Ninety Three and Cents Forty Seven (Rs. 73,664,680,693.47) for the service of the period beginning on 01st of January, 2026 and ending 31st December 2026, which is specified as "Financial Year 2026" in the Annual Financial Statement and Revenue and Expenditure Estimate for 2026 approved on 25.11.2025, as amended by the First and Second Supplementary Estimates for 2026 is hereby amended as, Rupees Seventy Six Billion Seven Hundred Thirty Four Million Eight Hundred Ninety One Thousand One Hundred Twelve and Cents Forty Seven (Rs. 76,734,891,112.47) and grant permission to the Chief Secretary of this Province and other Accounting Officers to disburse the same from the Sabaragamuwa Provincial Council Fund.
