THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Kuragamage Don Lal Kantha, Minister of Agriculture, Livestock, Lands and Irrigation do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are required for a public purpose and will be acquired under the provisions of that Act.

The allotments of land bearing the under-mentioned names and extents morefully described in the Advance Tracing No. CO/THI/2020/339 dated 09.11.2020, prepared by the Surveyor General, situated in the Village of Narahenpita (Division No. 41 – Colombo) in the Grama Niladhari Division of Kirula in the Divisional Secretary's Division of Thimbirigasyaya in the District of Colombo in Western Province and bounded as follows:
