Part III

This shall be amended as follows and all other matters shall remain unchanged.

7.2.2.2 Professional Qualifications:

- (c) Shall have acquired a qualification equal to or higher than the qualifications in 7.2.2.2 (a) or (b) above with regard to Library Science.

(Such qualifications shall be determined by the Director General of Combined Services, in consultation with the authorities of the relevant universities, the Sri Lanka Library Association and as the case may be, University Grants Commission)

7.2.4.3 General Interview: Marks will not be awarded.

Expected objectives to be achieved: Verification of Qualifications.

7.3.2.2 Professional Qualifications:

- (c) Shall have acquired a qualification equal to or higher than the qualifications in 7.3.2.2 (a) or (b) above with regard to Library Science.

(Such qualifications shall be determined by the Director General of Combined Services, in consultation with the authorities of the relevant universities, the Sri Lanka Library Association and as the case may be, University Grants Commission)

7.3.2.3 Experience:

- (a) (i) Shall have been confirmed in a post of Library Assistant/Library Employee of Departmental Primary Non-Skilled (PL - 01) Service category of the Public Service (excluding Provincial Public Services)

or

- (ii) Shall have been confirmed in a post which is formally certified by the Head of the Department as being actively and continuously engaged in Library-related duties and have completed a 10 year active period of service in the said post.

- (b) In the event that candidates have satisfied at least one of the qualifications specified in 7.3.2.2 (a), (b) and (c) above, it is sufficient for the said candidates to have been confirmed in a post mentioned in 7.3.2.3 (a) (i) or (ii) above and to have completed a 05 year active period of service in the said post by the prescribed date indicated in the notification for calling applications.

7.3.2.5 Other:

- (i) Shall have been confirmed in a post specified in 7.3.2.3 by the due date indicated in the notification calling for applications and shall not have been subjected to any disciplinary punishment in accordance with the provisions specified in the Public Service Commission Circular No. 01/2020 and consequent circulars and the same shall be certified by the Head of Department.

10.1.1.1 Qualifications to be satisfied:

- (iv) Shall not have been subjected to any disciplinary punishment in accordance with the provisions specified in the Public Service Commission Circular No. 01/2020 and consequent circulars and the same shall be certified by the Head of Department.
