Notice under Section 10

PROPOSED ORDER UNDER SUB-SECTION (2) OF SECTION 10

Every employer in Sri Lanka covered by the Wages Boards for Tea Growing and Manufacturing Trade, and the Rubber Growing and Manufacturing Trade established under the Wages Boards Ordinance, employing workmen covered by the said Wages Boards, on whom the Collective Agreement entered into between the Employers' Federation of Ceylon, which term shall mean and include the member companies whose names are mentioned in the annexed schedule hereto and referred to as the employer, and the Ceylon Workers Congress, the Lanka Jathika Estate Worker's Union, the Joint Plantation Trade Union Center, which term shall mean and include members of the said unions of the other part, on the 6th day of June, 2011 published under the heading "Collective Agreement No. 22 of 2011" in *Gazette* No. 1710/14 of 16th June, 2011 is not binding, shall observe the terms and conditions which are not less favourable than the terms and conditions set out in the aforesaid Collective Agreement.
