Painters, masons mates and blacksmith mates employed in repairing construction and maintenance of roads including Workers employed in cutting side drains secrifing the road surface, metal spreading loading unloading and filling of metal tarring roads and concrete mixing by hand.

Mechanical Engineering

Blacksmiths, strikers and hammer men, fettlers (iron and brass), smelters (iron and brass), checkers (timber), sawyers, caulkers (wood), boiler attendants, drivers (engine), firemen, tyre repairers, tyre vulcanizers, painters, bowmen, greasers, cleaners, washers.

Electrical Engineering

Wiremen, electroplaters.

Radio and Electronic Engineering

Assemblers, battery case manufacturers (radio), solderers, fixers (screw), sealer cabinet cleaners, cutters (chassis), benders, painters (boards, dials and badgers etc.), checkers anodisers, packers, power press operators, set testers, unit testers, etcher, (making of printed boards and transistors), buffing machine operators, sanding machine operators.

SKILLED WORKERS

Civil Engineering

Plumbers, blacksmiths, sign writers, polishers (appliers of French polish), masons, oil and steam roller drivers, ship wrights, body builders hood makers, miners (blastors and drillers sledgers, employed in repairing, constructing and maintenance of roads.

Mechanical Engineering

Turners, machinists (iron and steel working), machinists (wood working), coppersmiths, fitters, boiler makers, welders and burners, power hammer operators, moulders (iron and brass), joiners, core makers, pattern makers, carpenters, cabinet-makers, boat builders, saw sharpeners, machine knife sharpeners, launch tindals drivers, spilters, rope and sail makers, glazers, driver mechanics, tinkers (motor), tinsmiths, rivetters and caulkers, crane drivers.

Electrical Engineering

Electricians, armature winders, switch board attendants, radio and electronic technicians (radio), transformer makers, coil winder, casters, radio mechanics, polishers (radio cabinet and other parts), transformer winders and assemblers, tuner aligners.

Watchers engaged in all the categories

In this schedule, the word “Year” in relation to any trade learner or apprentice shall be deemed to consist of 365 days of continuous employment, and this training should be in plant training combusted by reputed Vocational Training Institute.

SCHEDULE

The decisions made by the Wages Board for the Motor Transport Trade, and set out in the Schedule to the Notification published in *Gazette* No. 9667 of 14th February, 1947 as varied from time to time and last varied by Notification in *Gazette Extraordinary* No. 1660/35 of 30th June, 2010, shall be further varied by the substitution for paragraph 6 in Part II of that Schedule of the following new part.

PART II

Minimum Wage

CLASS OF WORKERS

Class 'A' Workers -

Drivers of omnibuses licensed to carry over 22 passengers.

Class 'B' Workers -

Drivers of omnibuses licensed to carry over 22 passengers and under, drivers of ambulances and drivers of lorries and vans (other than those owned by an estate and used solely for internal transport within the estate) with a licensed payload of over 20 cwt.

Class 'C' Workers -

Drivers of hiring cars and cabs, drivers of lorries and vans (other than those owned by an estate and used solely for internal transport within the estate) with a licensed payload of 20 cwt. and under, drivers of three wheelers and drivers of hearses.

Class 'D' Workers -

Drivers of tractors with trailers used for transport purpose, drivers of lorries with trailers (including those of the scammel horse type but excluding those lorries with trailers or tractors owned by an estate and used solely for internal transport within the estate).

Class 'E' Workers -

Drivers of the following vehicles owned by an estate and used solely within the estate namely (a) lorries and (b) tractors with trailers.

Class 'F' Workers -

Conductors, clerks, cashiers, ticket - clerks and booking clerks employed in omnibuses.

Class 'G' Workers -

Cleaners and porters of lorries with a licensed pay load of over 20 cwt.

Class 'H' Workers -

Cleaners and porters of lorries with a licensed pay load of 20 cwt. and under, omnibuses, hiring cars, cabs, vans, ambulances and hearses.

Class 'I' Workers -

Omnibus checkers or time - keepers.

Class 'J' Workers -

Omnibus inspectors and omnibus stand supervisors.

Class 'K' Workers -

All other workers in the Motor Transport Trade excluding workers referred to in the preceding items.

In the foregoing decisions —

- (a) "Cleaners" means workers employed (other than in clerical capacities) in connection with the maintenance of the Mechanism of lorries, omnibuses, hiring cars, cabs, vans, ambulances or hearses ;
- (b) "Porters" means workers employed in loading or unloading goods in to or from lorries, omnibuses, hiring cars, cabs, vans, ambulances or hearses and required to travel in the vehicles in the performance.
