#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Eleven (11) allotments of land described as Lots 'A' - 'L', in total extent of about 0.5924 Hectare, in Advance Tracing Nos. RKLW/2009/288A and RKLW/2009/288B of 24th September 2009, prepared by the Surveyor-General, situated in the village of Koswatta, Meda Pattuwa Minor Division, in Kukul Korale, in the Divisional Secretary's Division of Kalawana in Rathnapura District in Sabaragamuwa Province and bounded as follows:

##### Public Purpose of Acquisition

Acquired for the purpose of Koswatta Ganga Mini Hydro Project.
