Government Notifications

SRI LANKA EXPORT DEVELOPMENT ACT, No. 40 OF 1979

Order under Section 14

BY virtue of the powers vested in me by Section 14(1) of the Sri Lanka Export Development Act, No. 40 of 1979, I, Rishad Bathiudeen, Minister of Industry and Commerce, with the concurrence of the Minister of Finance and Planning, do by this order declare that,

- (I) A Cess shall be charged, levied and paid on import of any article specified in the Column II and Column III at the rates specified in the corresponding entry in Column IV in the Schedule I hereto, with effect from 03rd September, 2012. Accordingly, the respective Cess rates for articles specified under HS Headings 69.07, 69.08, 69.10, 69.11, 69.12, 69.13 and 69.14 mentioned in *Gazette Extraordinary*, No. 1733/6 dated 21.11.2011, are hereby revised;

And

- (II) Cess charged on import of selected articles specified under HS Headings 07.12 and 72.13 in the schedule II hereto, mentioned in the Schedule of the *Gazette Extraordinary*, No. 1764/5, dated 27.06.2012, is hereby removed ;

with effect from 03rd September 2012.
