THE UNIVERSITIES ACT, No. 16 OF 1978

ORDINANCE made by the University Grants Commission under Section 18 read with Sub-section (2) of Section 24A of the Universities Act, No. 16 of 1978.

Ordinance

1. This Ordinance may be cited as the Postgraduate Institute of Science (Amendment) Ordinance No. 1 of 1996, and shall come into operation with effect from April 25, 2012.

2. The Postgraduate Institute of Science Ordinance No.1 of 1996 published in *Gazette Extraordinary* No. 909/13 of February 9, 1996 is hereby further amended, by the repeal of paragraph 9 thereof and the substitution therefor of the following paragraph : -

"9. The Board of Management, (hereinafter referred to as the "Board") shall function as the academic and executive body of the institute and shall consist of the following persons :-

(1) the following ex-officio members, namely -

- (a) the Director;
- (b) the Secretary to the Ministry of the Minister to whom the subject of Higher Education is assigned, or the nominee of such Secretary ;
- (c) the Secretary to the Ministry of the Minister to whom the subject of Finance is assigned, or the nominee of such Secretary ;

 - (d) the Secretary to the Ministry of the Minister to whom the subject of Science and Technology is assigned, or the nominee of such Secretary ;
 - (e) the Director General, National Science Foundation functioning under the Ministry of Science and Technology ;
 - (f) the President, Federation of Chamber of Commerce and Industry of Sri Lanka or his nominee ;
 - (g) the Dean, Faculty of Science of the University of Peradeniya;
 - (h) one other Dean to represent the Faculties of Science of all Universities, established under the Universities Act, No. 16 of 1978 (excluding the University of Peradeniya) who shall be nominated by the Standing Committee on Science of the University Grants Commission, established under the aforesaid Act; and
 - (2) the following other members, namely-
 - (a) two members appointed by the aforesaid University Grants Commission ; and
 - (b) one member to represent each Board of Study of the Institute elected by the members of such Boards of Study from among themselves".

3. Amendment to the Postgraduate Institute of Science Ordinance No. 1 of 1996 published in *Gazette* No. 1755/33 of April 25, 2012 is hereby rescinded.
