REGULATION made by the Minister of Health under Section 38 of the Cosmetics, Devices and Drugs Act, No. 27 of 1980, as amended by Act, No. 38 of 1984, Act, No. 25 of 1987 and Act, No. 12 of 1993 read with Section 11 of this Act.

The Drugs Regulations No. 38 of 1984 published in *Gazette Extraordinary* No. 378/3 of December 2, 1985 as amended by Regulation published in *Gazette Extraordinary* No. 722/2 of July 6, 1992 is hereby further amended by the insertion immediately after regulation 83 thereof, of the following regulation, which shall have effect as regulation 83A :-

"83A. (1) Every advertisement made to the general public by the use of the electronic medium or the print media or by way of being printed on the labels, packaging or in inner product information leaflets relating to -

- (i) Paracetamol syrup shall contain the statement "do not exceed recommended dose and frequency, as excessive dosage could be harmful to the liver. If fever presists consult your doctor."; and
- (ii) Paracetamol tablet shall contain the statement "do not exceed recommended dose and frequency, as excessive dosage could be harmful to the liver. If sympotms presist consult your doctor.".

(2) This regulation shall come into operation upon the expiry of a period of two months from the date of publication of such regulation in the *Gazette*.".
