### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Munasingha Kariyawasam Appuhamilage Don Somadasa Gunawardana, Minister of Lands hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of below mentioned lands in total extent of about 0.1157 Hectare, depicted in the Advance Tracing No. MR/HKM/2014/422 and dated 20th November, 2014, situated in the Village of Denagama (FVP 178) in Minor Division of Kandabada Pattuwa East in the Divisional Secretary's Division, of Hakmana in Matara District, Southern Province and bounded as follows:

**01. Lot 'A' – Mulane Athmaga or Badaldeniya Athmaga – Extent: 0.0005 Hectare**

North: Heenidukuttiya claimed by H. S. P. Lamahami and others, Denagama Wewa and Lot F; East: Lot F and Road (R.D.A.); South: Road (R.D.A.); West: Heenidukuttiya claimed by H. S. P. Lamahami and others.
