THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

My Reference No.: DST/LND/1/ACQ/76.

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as Amended by the land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land/servitude\* which is required for a public purpose:

Description of the Land or Servitude to be acquired:

Lot No. 150, 151 and 152 (Lots 03) allotments in total extent of about 0.0273 Hectare of lands name of Polkoratuwa and Ambalagewatta, Achariyawatte Kumbura *alias* Achariyawatta Kebella of land in Final Village Plan No. 313 and dated 04.09.2015 prepared by the Surveyor-Superintendent on behalf of Surveyor-General situated in the Village of Polommaruwa the Gramaniladhari Divisions Polommaruwa North and Polommaruwa South in the Minor Division of Giruwa Pattuwa-Western of Divisional Secretary's Division of Tangalle in Hambantota District in the Southern Province and bounded as follows.
