SRI LANKA EXPORT DEVELOPMENT ACT, No. 40 OF 1979

Order under Section 14

BY virtue of the powers vested in me by Section 14(1) of the Sri Lanka Export Development Act, No. 40 of 1979, I, Malik Samarawickrama, Minister of Development Strategies and International Trade with the concurrence of the Minister of Finance, do by this order declare that, a Cess shall be charged, levied and paid on import of any article specified in the Column II and III of the Schedule hereto at the rate specified in the corresponding entry in Column IV in the Schedule hereto, with effect from 14.12.2015, Accordingly, for every article specified under the H. S. Headings 0511.91.90, 1404.90.10, 2710.19.80, 3214.90.90, 3816.00, 3824.50, 3824.60, 3903.90.10, 3905.12, 3905.21, 3906.10.10, 3906.10.90, 3906.90.10, 4410.11.90, 5804.10.19, 6401.10, 6401.92, 6401.99, 6402.12, 6402.19, 6402.20, 6402.91, 6402.99, 6403.12, 6403.19, 6403.20, 6403.40, 6403.51, 6403.59, 6403.91, 6403.99, 6404.11, 6404.19, 6404.20, 6405.10, 6405.20, 6405.90, and 8418.91.10 mentioned in the Column I of the Schedule of the *Gazette Extraordinary* No. 1941/33 dated 20.11.2015, the respective Cess rates mentioned in the corresponding entry in Column IV of that Schedule are hereby repealed with effect from 13.12.2015.
