SPECIAL COMMODITY LEVY ACT, No. 48 OF 2007

Order under Section 2

BY virtue of the powers vested in me under section 2 of the Special Commodity Levy Act, No. 48 of 2007, I, Ravi Karunanayake, Finance Minister of the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of the commodity items specified in "Column I" of the Schedule hereto a Special Commodity Levy, at the rates specified in the corresponding entries in Column II of that Schedule. This order shall be valid for a period of 04 months commencing from 17th June 2015, subject to provisions of Sub-section (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.
