Notice under Section 7

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land/servitude which are required for the public purpose.

Description of the Land /Servitude to be Acquired:

Lot No. 838, 839, 840 as depicted in the Sheet No. 36 and the Extra No. 34 in the Final Village Plan No. 208 prepared by the Superintendent of Surveyor Rathnapura, situated in the Grama Niladhari Division of 172 Lellopitiya in Meda Paththuwa in the Divisional Secretary's Division of Pelmadulla of Rathnapura District in Sabaragamuwa Province.
