I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the land described below to create a water reserve in the paddy field located between 120 bus route and the sub canal stretches towards Piliyandala Gangarama Road from the Maha Ela at Bokundara under Werar Ganga Storm Water Drainage & Environment Improvement Project.
