Provincial Councils Notifications

CENTRAL PROVINCE PROVINCIAL COUNCIL

IN accordance to the Schedule Eight of the 13th Amendment of the Consitution of the Democratic Socialist Republic of Sri Lanka the powers vested on the Provincial Council as per the Regulations 24 (2) (1) (xii) and 24 (3) of the Route Passenger Transport Act, No. 04 of 1992 and by the order under Section 20 of the regulations of the Passenger Transport Service Authority Statute No. 01 of 2000.

I, Ediriweera Weerawardana, Minister of Central Province Road Development, Transport, Power and Energy and Housing and Construction by the Provincial Council as per the regulations 24 (2) (1) (xii) and 24 (3) of the Route Passenger Transport Act, No. 04 of 1992 and by the order under Section 20 of the regulations of the Passenger Transport Service Authority Act, No. 01 of 2000 and on the powers vested on me and in accordance to the Special *Gazette* Notification No. 1990/27 of the Democratic Socialist Republic of Sri Lanka dated 27th October, 2016 it is hereby ordered as published in this *Gazette* that in respect of the new system of Passenger Transport by the order constituted and in addition to the order the following orders by the Central Province Passenger Transport Service Authority shall be followed.

01. (i) It should be declared to recognize a transport Unit either by incorporating one Bus route service or several Bus routes together within the area of a Bus route from the date of the order of the Minister within a period of Twelve months by the Central Province Passenger Transport service,
- (ii) The appointment of a manager for the administration of the new system of the route Unit as declared,
- (iii) To incorporate a Route Administration room for the route unit for one or more as declared.
02. (i) From the date of announcement of the Route Unit by the Central Province Passenger Transport Service or specially within the period the permit holders of a route or several routes shall provide transportation to such route or routes as authorized by the permit under the administration under the Manager appointed by the Authority on behalf of such passenger service of the route and to abide by the advice and time table laid down by the manager from time to time and to render an efficient bus service accordingly.
- (ii) The Permit Holders shall provide suitable passenger transport by rendering and maintaining an efficient service and to install and use a GSP Equipment to the bus with the facility of installing and using the facilities of a CCTV camera and the utilization of a post payment card to issue electronic tickets by way of G. R. P. D. Equipment Technology.



(iii) All income derived daily shall credit all proceeds to the account maintained in the name of the Central Province Passenger Transport Service opened for this purpose in the Government Bank. From this income the service for prepaid Cards shall be deducted and the full balance of the income for the bus plying on the same day in accordance to the proportion of the pre budget shall be deposited to the owner of the bus accordingly.

03. In accordance to the Order No. 01 All route Buses in the Central Province shall abide the regulations set out in this *Gazette* from the date of publication,

04. Further it is declared to nominate not more than eight members to render suggestions and ideas for the purpose of development and improvement of this service and to incorporate a transport unit or several units for the management an advisory committee to be nominated this committee shall provide Advice services to increase the income, distribution of income, Salaries to Employees and a method to secure their social security and bus maintenance thereof,

05. All service administration and the power of the comfortability of passengers and the introduction of new service shall be sole vested with the Central Province Passenger Transport Service,

06. (i) The Central Province Passenger Transport Service shall announce the auditors to a declared transport Unit for the purpose of accounting the financial and technical auditing.

(ii) To keep the Audit reports open for inspection at all times to all permit holders of a transport unit or to each and every Route or the Central Province Passenger Transport Service shall provide such facilities.

(iii) Further the said Auditor shall forward to the Provincial Council through the relevant the yearly Audit.
