**Uva Provincial Council Charter of Library Services Board (Amendment) Act, No. 04 of 2017**

A charter design to amend the Uva Provincial Council charter of library services board

Imposed as below by the Uva Provincial Council of Democratic Socialist Republic of Sri Lanka.

Short name and activation date.

1. This charter is termed as Uva Provincial Council charter of library services board (Amendment) Act, No. 04 of 2017. If it is not mentioned in any other way, then, it will be activate from the day Governor of the Uva province approves it.

Adding the 3 (A) new sub paragraph to the main charter.

2. Here onwards 2000 number 05 - Uva Provincial Council charter of library services board will be recognized as the "Main Charter". The new sub paragraph below will be added after 3(A) Sub Paragraph of Main charter. It will be imposed as the 3 (A) Sub Paragraph of Main charter.

3(A) Library development and establishment of unity (oneness) within provincial library services by processors such as Colletive planning to spread Library services, Centralized and integrated database development, Preservation of library materials, Development of regional collections and acquisition process, Inter library interchange and loan systems, Establishment of mobile libraries, Establishment of information networks.

Adding the 6 (A) (I) (a) new sub paragraph to the main charter.

3. The new sub paragraph below will be added after 6 (A) (I) (a) Sub Paragraph of Main charter. It will be imposed as the 6 (A) (I) (a) Sub Paragraph of Main charter.

6 (A) (I) (a) Secretary of Provincial Ministry of Cultural Affairs

Adding the 6 (B) (I) and (II) new sub paragraph to the main charter.

4. The new sub paragraph below will be added after 6 (A) (I) (a) Sub Paragraph of Main charter. It will be imposed as the 6 (B) (I) and (II) Sub Paragraphs of Main charter.

Duty of the Chairman of the Board.

6 (B) (I) Chairman who appointed by Education minister should be the in -charge of the Director Board Meetings. He/she should be the chief Executive officer of the board. It is his/her responsibility to direct the library services board according to government and provincial charters.

Quorum of the Director Board Meetings.

6 (B) (II) Quorum of the Director Board Meetings should be five members.

Sinhala charter wordings should be imposed in inconsistency.

5. If there are any Inconsistencies within Sinhala and Tamil translations of this charter, then, Sinhala charter wordings should be imposed.
