A STATUTE TO AMEND THE APPROPRIATION STATUTE No. 02 OF 2006 AS AMENDED BY APPROPRIATION STATUTE No. 02 OF 2007 AND STATUTE No. 07 OF 2016 OF THE SABARAGAMUWA PROVINCIAL COUNCIL OF THE DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA

1. This Statute may be cited as the Sabaragamuwa Provincial Council Appropriation (Amendment) Statute No. 11 of 2017, and shall come into operation of the date of receiving the assent of the Governor of the Sabaragamuwa Province.
2. The limits mentioned in the Advance Account namely 8333 in the Second Schedule of the Appropriation Account No. 02 of 2006 as amended by Appropriation Statute No. 02 of 2007 and No. 07 of 2016, is hereby amended as per the first schedule hereof.
