Declaration under Section 07

I, do hereby give notice under Sub -section (i) Section 07 of Land Acquisition Act, that the State intends to acquire the following lands which is required for a public purpose.

Description of the land to be acquired:-

Eight Lots (08), (20 - 28) in Total Extent of 0.2716 Hectares, as depicted in the Final Village Plan No.420, Supplement No. 5/ Sheet No.5 of 08.03.2017 prepared by the Senior Superintendent of Surveys, Kurunegala on behalf of Surveyor General, situated in the Village of Nungamuwa in Grama Niladari Division No.967 Nungamuwa Pahala, in Divisional Secretary's Division of Alawwa in Kurunegala District North Western Province. In addition to said documents the amount of the compensation and details of the compensation should submit in two copies. If an agent present at the inquiry,

he/she should submit a duly authorized letter from the original claimant. Without such a letter any statement or evidence will not be recorded from the agent at the inquiry.
